3. The Contractor shall state the time would be required to complete the job which will not exceed **Three Week** from the date of work order.
4. For non-completion of work in specification time the Contractor shall be liable to pay the client 'Agreed Liquidated Damage" at the rate of Rs. 200/- per day
5. The materials and workmanship shall comply with the relevant codes of practice.
