- 3) Bidder should have satisfactorily completed one work of similar nature or any other civil work of estimated cost not less than Rs.1.5 Lakh, during last 3 years.
- 4) Bidder should have average annual financial turnover of value not less than Rs.9 Lakh. Bidder will be required to submit the annual turnover certificate of last three financial years (FY- 2015-2016,2016-2017,2017-2018.) issued by the Chartered Accountant.
- 5) The bidder should be registered with Employees Provident Fund Organization. The copy of registration should be attached.
