

16) In case of any dispute the same will be subject to the jurisdiction of the competent court at Rahata / Kopargaon.

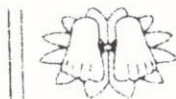
