❖ Minimum Qualifying Criteria:

- 1) The bidder should submit the cost of blank tender document Rs.590/- and EMD of Rs.18,000/- through online payment on www.mahatenders.gov.in
- 2) The bidder should be registered as a contractor with PWD or any other Govt. dept. in appropriate class. The registration copy should be attached.
- 3) The bidder must have successfully completed the projects as below, during the last 05 financial years ending 31st March 2026. The bidder is required to submit its Work Order and Completion Certificate issued by the Clients.
 - 03 similar types of works whose amount is not less than Rs.7.25 Lakhs each.
 - OR
 - 02 similar types of works whose amount is not less than Rs.9.0 Lakhs each.
 - OR
 - 01 similar type of work whose amount is not less than Rs.14.50 Lakhs each.
- 4) The bidder should have a maximum annual financial turnover of at least Rs.40.50 lakhs, in any one year of the last 05 financial years, (FY-2020-21, 2021-22, 2022-23, 2023-24 and 2024-25). The bidder shall submit the certificate issued by the CA.
- 5) The bidder should be registered with Employees Provident Fund Organization. The copy of EPF registration should be attached.
- 6) The bidder should be registered with GST Dept. The copy of GST registration should be attached.
