Bidders Scope of Work:-

1. The work includes uninstallation (Dismantling) of existing 2 Nos. LED Screens with carefully without any damage and to be carried at other Sansthan Temple premises locations for reinstallation, fabrication, commissioning with ACP (Aluminum Composite Panel) work.
2. LED Screen panels should be bounded by M.S. angle 50mm x 5mm and for back support M.S. angle 35mm x 5mm.
3. For taking up LED screen at the height of 8 feet from ground level bidder should use 50mm x 5mm M.S. angle box frame.
4. Back support of 35mm square M.S. pipe of 3mm thickness of the cabinates to ensure good strength to ensure safety of the fabrication.
5. ACP frame work of 1 ft should be done at all 4 sides of the display and pole box frame as well as back side of display to cover all direction except fornt side.
6. Electrical power connection will be provided near LED Screen, further connection work should be carried out by the bidder.
7. Total fabrication work, erection, installation and commissioning of LED screens is in bidder's scope.
8. Bidder should quote the price inclusive of transport, labour, PCC work for Pole, Painting till completion and commissioning of the both displays.
9. Bidder should ensure quarterly visit to Sansthan for verification and maintenance purpose of Both LED Screens, cost for the same should be included in the quotation. Charges quoted separately for maintenance and visit will be considered as non-responsive n same should be rejected.
