- 5) Bidder should have average annual financial turnover of value not less than Rs.13 lakhs, during last 03 years. (FY-2015-16, 2016-17, 2017-2018). Profit & Loss statement and CA certificate should be attached along with technical details.
- 6) The bidder should be registered with Employees Provident Fund Organization. The copy of registration should be attached.
- 7) Bidder should submit GST Registration copy and PAN card copy.
