MINIMUM QUALIFYING CRITERIA

Name of Work:	Construction of Shri Saibaba Educational Complex at GAT No. : 183, Nimgaon Korhale, Tal Rahta, Dist Ahmednagar, Maharashtra, for Shri Saibaba Sansthan Shiridi. (Lump Sum C-Form Tender).
Ref.:	E-tender notice published in the newspaper and on Sansthan's website.
The following copies of original / attested documents should be scanned & uploaded online.	

- 1) Tender document fee Rs.11,800/- (Rs.10,000 +18% GST) by online payment on www.mahatenders.gov.in.
- 2) EMD of Rs.1,26,99,200/- by online payment on www.mahatenders.gov.in.
- 3) Joint venture not permitted.
- 4) Bidder should have satisfactorily completed at least one single work of any similar RCC framed structure with approximately 40,000 sqm of building area, including 13,000 sqm of basement with waterproofing and estimated cost not less than Rs.95Crores in last 03 financial years. (2015-16,2016-17,2017-18)
- 5) Bidder should have average annual financial turnover of value not less than Rs.100 Crores. Bidder will be required to submit certified and audited balance sheets and the avg. annual turnover certificate of last 03 financial years issued by Chartered Accountant. (2015-16,2016-17,2017-18)
- 6) Bidder should have a solvency of value not less than Rs.55Crores. The bidder will be required to submit the bank certificate.
- 7) The bidder should be registered with Employees Provident Fund Organization. The copy of registration should be attached.
- 8) The bidding capacity of the bidder should be equal to or more than the estimated cost of the work. The bidding capacity shall be worked out by the following formula:
Bidding Capacity = $A \cdot N^2 - B$.
Where,
A = Maximum value of civil engineering works executed in anyone year during the last 05 years (updated to the price level of the year indicated in Appendix) taking into account the completed as well as works in progress.
N = Number of years prescribed for completion of the works for which bids are invited (18 months).
B = Value (updated to the price level of the year indicated in Appendix) of existing commitments and on-going works to be completed during the next ... Years (Period of completion of works for which bids are invited).
Note: The statements showing the value of existing commitments and on-going works as well as the stipulated period of completion remaining for each of the works listed should be countersigned by the Engineer in Charge, not below the rank of an Executive Engineer or Architect / Consultant.
The bidders should workout the bidding capacity according to aforesaid formula and submit it along with the supporting documents.
- 9) Contractor should have a valid ISO & OHSAS Certification
- 10) The bidder should own construction equipments required for the proper and timely execution of the work. The bidder should submit the current usage of owned construction equipments stating name of projects. For this project an owned batching plant of 60 cum/hr and a Tower crane of 50 mts jib length is essential to be deployed at site. The same has to be authenticated with proof of ownership.

- 11) The bidder should have sufficient number of technical staff for the proper execution of the contract. The bidder should submit a list of these employees stating clearly whom out of these are likely to be involved in this work, if work is awarded.
- 12) Bidder should name management person who would be available for deliberation of the project during execution and would be available in critical review meetings.
- 13) Bidder should submit an undertaking that he is not barred / not blacklisted by any Client including State / Central Govt. Department/ PSU's.
- 14) Bidder should submit Arbitration / litigation records. If the bidder has no such record, he should submit an undertaking accordingly.
