- The bidder should submit the EMD of Rs.23,500/- through Online payment on Government website www.mahatenders.gov.in.
- ❖ Bidder should have satisfactorily completed One work of similar nature of estimated cost not less than **Rs.17.40Lakhs** or Two works of similar nature of estimated cost not less than **Rs.11.60Lakhs** during last five years.
- ❖ Bidder should have maximum annual financial turnover of value not less than Rs.52Lakhs during last five financial years.(2016-17, 2017-18, 2018-19, 2019-20, 2020-21). CA certificate should be attached.
- The bidder should be registered as a contractor with PWD or any other Govt. Department in appropriate class. The PWD registration copy should be attached.
