General Term & Conditions

1. "PRE –BID Meeting" with the intending bidders shall be held on 23/03/2018 at 11:00 A.M. onwards at Shri Saibaba Temple Complex, Shirdi. All the prospective bidders are requested to send comments/ representations on or before pre-bid meeting.

2. Validity:

a)The quoted rates must be valid for a period of 180 days from the last date of Submission of the tender. The overall offer for the assignment and bidder(s) quoted price shall remain unchanged during the period of validity. If the bidder quoted the validity shorter than the required period, the same will be treated as unresponsive and it may be rejected.

b)In case the tenderer withdraws, modifies or changed his offer during the validity period, bid is liable to be rejected and the earnest money deposit shall be forfeited without assigning any reason thereof. The tenderer should also be ready to extend the validity, if required, without changing any terms, conditions etc. of their original tender.

- d) Pre-Qualification Criteria in Annexure-III

3. Technical Evaluation:

- (a) Detailed technical evaluation shall be carried out by Shri Saibaba Sansthan Trust, shirdi pursuant to conditions in the tender document to determine the substantial responsiveness of each tenderer. For this clause, the substantially responsive bid is one that conforms to all the eligibility and terms and condition of the tender without any deviation. Determination of bid's responsiveness is to be based on the contents of the bid itself without recourse to extrinsic evidence. Shri Saibaba Sansthan Trust, Shirdi, shall evaluate the technical bids also to determine whether the quoted specifications as per the catalogue submitted match the required technical specification mentioned in Annexure I & II. they are complete, whether the documents have been properly signed and whether the bids are in order.
- (b) If the specifications of the quoted make and model do not match with the specifications mentioned in Annexture I & II, the bidder shall be disqualified in Technical Evaluation.
- (c) Shri Saibaba Sansthan Trust, Shirdi, shall have right to accept or reject any or all tenders without assigning any reasons thereof.

4. Financial Evaluation:

- (a) The financial bid shall be opened of only those bidders who have been found to be technically eligible. The financial bids shall be opened in presence of representatives of technically eligible bidders, who may like to be present. The Shri Saibaba Sansthan Trust, Shirdi, shall inform the date, place and time for opening of financial bid.
- (b) After due evaluation of the bid(s) Shri Saibaba Sansthan Trust, Shirdi, will award the contract to the lowest evaluated responsive tenderer. Conditional bid will be treated as unresponsive and will be rejected.
- 5. Award of Contract: Shri Saibaba Sansthan Trust, Shirdi, shall consider placement of orders for jobs on those bidders whose offer s have been found technical and financially acceptable.
- 6. Signing of Contract: The successful bidder shall be required to execute the Contract Agreement accepting all terms and conditions stipulated herein on a non-judicial stamp paper of Rs. 500/- (Rs. Five Hundred only) within fifteen days of the issue of the Letter of notification of award along with performance security. In the event of failure on the part of the successful bidder to sign the Contract within the period stipulated above, the EMD shall be forfeited and the acceptance of BID shall be considered as cancelled.
- **7. Security Deposit :** The successful tenderer will be required to furnish a Security Deposit of 5 % of order value The Security Deposit shall be refunded after expiry of Defect Liability Period. No intrest shall be paid on security Deposit.
- 8. **Demonstration:** The bidders may be asked to demonstrate the product as and when required by Shri Saibaba Sansthan Trust, Shirdi failing which their bids/offer shall be rejected. The firms are intimated that they should get ready for demonstration and only 15 days time will be provided for arrangement of demonstration and no request for extending time for demonstration will be entertained. Failure to demonstrate, their offer will be summarily rejected. The expenditure incurred for demonstrating the items will be borne by the supplier, no Claim in this regard will be entertained.

- 9. **Rate:** Prices of individual items should include packing, forwarding, transport, insurance, loading/ unloading, installation and GST.It Should also include warranty and Defect Liability Charges. Rate should be quoted only in Indian Rupees (INR) on DOOR Delivery Basis at Shri Saibaba Sansthan Trust, Shirdi, Inclusive of all the charges, with break-up as:
 - Basic Cost.
 - GST and Other taxes.
 - Total Cost (F.O.R. at Shri Saibaba Sansthan Trust, Shirdi).
- 10. **Manufacture authorization Certificate:** The bid must be submitted by manufacturer or authorized distributor. The bidders are required to provide manufacturer's authorization certificate on company's letterhead along with the technical bid (Documentary proof must uploaded with technical bid).

11. Warranty:

- (a) The Tenderers quote must include 02 years comprehensive on-site warranty (Including all Spares, Accessories and Labour) from the date of completion of the satisfactory installation. And also Comprehensive Defects Liability Period Maintenance must be minimum 03 years after Comprehensive on-site Warranty. The warranty and Comprehensive Defects Liability Period Maintenance charges shall not be quoted separately otherwise the offer shall be summarily rejected. Failure to comply this condition will entail the rejection of the bids.
- (b) No offer of the vendor will be accepted without warranty/ guarantee of their supplied/ installed goods.

12. Downtime penalty Clause:

- (a) The Bidder or their authorized service providers are required to submit a certificate that they have satisfactory service arrangements and fully trained staff available to support the uptime guarantee.
- (b) Comprehensive on-site warranty of 02 years is responsibility of the supplier. If the supplier fails to provide quoted services of the Warranty period, then a penalty at the rate of 0.2% per day of the total order value will be charged from the supplier.
- 13. Authority of person signing document: A person signing the tender form or any documents forming part of the contract on behalf of another shall be deemed to warranty, that he has authority to bind such other and if, on enquiry, it appears that the person so, signing had no authority to do so, Shri Saibaba Sansthan Trust, Shirdi may without prejudice to other Civil and criminal remedies cancel contract and hold the signatory liable for all cost and damages.
- 14. **Delivery and Installation**: The items shall be delivered and successfully installed/ commissioned within 15 **days** from the issue of supply order from Shri Saibaba Sansthan Trust, Shirdi. The successful tenderer will also provide required training to the Gym. staff free of cost for supplied items at Shri Saibaba Sansthan Trust, Shirdi. The goods shall be manufactured by adopting latest technology.

All the aspects of safe delivery, installation and commissioning is the exclusive responsibility of the supplier. If the supplier fails to deliver, install and commissioning the goods on or before the stipulated date, then a penalty at the rate of 0.5% per week of the total order value shall be levied subject to maximum of 5% of the total order value.

In the case of package supply where the delayed portion of supply materially hampers installation and commissioning of the systems, liquidated damage charges shall be levied as above on the total value of the concerned package of the purchase order. Quantum of liquidated damages assessed and levied by the purchaser shall be final and not challengeable by the supplier.

15. **Right of acceptance:** Shri Saibaba Sansthan Trust, Shirdi reserves the right to accept the whole or any part or portion of the bid; and the bidder shall provide the same at the rates quoted. Shri Saibaba Sansthan Trust, Shirdi reserves the right to reject any or all tenders or all offers received in response to the tender or cancel or withdraw the tender notice without assigning any reason thereof and also does not bind itself to accept the lowest quotation or any tender and no claim in this regard shall be entertained.

16. Inspection:

- (a) Shri Saibaba Sansthan Trust, Shirdi shall have the right to inspect and/or to test the goods to establish their conformity to the NIT Specifications at no extra cost to the Purchaser.
- (b) Shri Saibaba Sansthan Trust, Shirdi right to inspect, test and, wherever necessary, reject the Goods after the goods arrival at the final destination it shall in no way be limited or waived by reason of the Goods having previously been inspected, tested and passed by Shri Saibaba Sansthan Trust, Shirdi prior to the goods shipment.
- (c) Shri Saibaba Sansthan Trust, Shirdi shall be the final authority to reject full or any part of the supply which is not conforming to the specification and other terms and conditions.
- (d) No payment shall be made for rejected Stores. Rejected items must be removed by the Bidders within two weeks of the date of rejection at their own cost and replaced immediately. In case these are not removed, these will be auctioned at the risk and responsibility of the suppliers without any further notice.

- 3. **5** % paid after Completion of Defect Liability Period.
- 19. Specification: Bids which are not meeting the bid specifications are not permitted and will be rejected.
- 20. **Experience:** Bidder should have at least 5 year experience in supply and Installation of indoor Gym. Equipments. (Documentary proof must upload with technical bid). Bidders who do not have the requisite experience will be rejected.
- 21. **Breach of Terms and Conditions:** In Case of breach of any terms and conditions as mentioned above, the Competent Authority, will have the right to reject the bid at any stage without assigning any reason thereof and nothing will be payable by Shri Saibaba Sansthan Trust, Shirdi.In that event the EMD shall also stands forfeited.
