- ❖ Bidder should have satisfactorily completed at least one single work of Similar Nature of estimated cost not less than Rs.38.60 lakhs in last 05 financial years. (2025-21, 2021-22, 2022-23, 2023-24, 2024-25)

Bidder should have satisfactorily completed two works of Similar Nature of estimated cost not less than Rs.24.12 lakhs each in last 05 financial years. (2025-21, 2021-22, 2022-23, 2023-24, 2024-25)
OR
Bidder should have satisfactorily completed three works of Similar Nature of estimated cost not less than Rs.19.30 lakhs each in last 05 financial years. (2025-21, 2021-22, 2022-23, 2023-24, 2024-25)
