2. Applicant must have experience in this field of Statutory Audit/ Internal Audit/ Tax Audit of Company/ Firm/Trust or any Institutions having Annual Turnover Rs.500 Crores & above in last three years. (must attach copy of Appointment Order of the Clients and valid proof of turnover i.e. P&L/Balance Sheet/Declaration etc. and no need to attach Audit Firms own Turnover details)
3. With considering the volume of transactions of Sansthan, we have required minimum manpower as per the details in the chart given below.
